**2010 BACKYARD GARDENER APPLICATION**

The Port Coquitlam Farmers Market offers Community spaces at each of our Thursday markets. This Application is specifically for those selling fruit and vegetables grown in their backyards or at their community garden site. You will be provided with a portion of a table under a 10x10 tent. You are sharing this space with other backyard gardeners. Cost is \$5.00 which covers three markets and is for a 2' space or 1/3 of a table. If you need a larger area, the cost is an additional \$5 per 1/3 table. This fee is paid in advance and is non refundable. If needed there is electricity in the Park, please bring a long 3-prong outdoor extension cord.

**Pricing of your goods must be competitive with those items already being sold at the Market. The quality of the product must be of the highest caliber. The product and its price will be checked upon arrival. The PCFM reserves the right to refuse space to a vendor.**

To be covered under our insurance and business license all vendors must be members of the Port Coquitlam Farmers Market. Membership is \$25 per year. If your own insurance will cover you **please send a copy of this or a letter stating your coverage** with your application and the membership charge will be waived.

The Port Coquitlam Farmers Market hours are from 3 – 7 pm. every Thursday during our regular market season from approximately May until September. It is held at 2253 Leigh Square off Shaughnessy between McAllister and Wilson Streets in downtown Port Coquitlam.

For safety reasons we ask that all vendors and other groups have their vehicles removed from the market area 30 minutes before the market begins. All booths must be set up at least 15 minutes before the market begins. All vendors and groups must remain set up on site until close of market. This is an outdoor market which will run rain or shine.
